___ **Regular Membership** – Any Attorney licensed to practice in Pennsylvania whose residence is in Bucks County, or who maintains a principal office for the practice of law in Bucks County, or who is employed in Bucks County in a law related capacity by an agency or corporation or other entity, is eligible for regular membership in the Association. "Principal office" is the place where the attorney spends the greater part of his/her working hours, even if it is a branch of a law firm that has its principal office outside the county.

___ **Associate Membership** – For those attorneys who are not eligible for regular membership who shall be entitled to participate in educational, social and committee functions as a nonvoting member.

___ **County/State/Legal Aid Employee** – For full time employees of the County of Bucks, the Commonwealth of Pennsylvania or Legal Aid of Southeastern Pennsylvania.
