ORDER

AND NOW, this 30th day of March, 2020:

The Court having declared a Judicial Emergency in the 7th Judicial District of Pennsylvania on March 17, 2020, and in light of subsequent orders restricting the operations of the Magisterial District Courts, it is hereby ORDERED that the following precautionary measures affecting all Magisterial District Court offices of the Seventh Judicial District will remain in place until further order of the Court of Common Pleas.

The District Courts will be divided into three (3) geographical groups as follows:

All Magisterial District Courts will be closed to the public EXCEPT as designated in the attached schedule. Those courts will remain operational as scheduled, pursuant to Emergency Order Nos. 2020-02 and 2020-03. There will be one (1) designated District Court open for Upper and Central Bucks County and two (2) designated District Courts open for Lower Bucks County.

This Order is effective April 2, 2020, and, unless extended by further order, shall expire at the close of business April 14, 2020.
