The Court having declared a Judicial Emergency in the 7th Judicial District of Pennsylvania on March 17, 2020, and in light of subsequent orders restricting the operations of the Magisterial District Courts, it is hereby **ORDERED** that the following precautionary measures affecting all Magisterial District Court offices of the Seventh Judicial District will remain in place until further order of the Court of Common Pleas.
